Crossroads RV (Crossroads) has decided that a defect which relates to motor vehicle safety exists in certain model year 2015 and 2016 travel trailers. As a result, Crossroads is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall	It has been decided that on certain Crossroads travel trailers, the liner which seals the back of the propane cooking range may have been omitted during vehicle assembly. This gap may allow air to move to and from the range area, creating a draft that can affect the safe operation of the range increasing the risk of fire, causing injury and/or damage to property.
What we will do	Crossroads will install a divider wall panel to separate the range from the body of the trailer. This will be done at no cost to you, the owner.
What we need you to do	At your earliest convenience, contact your servicing dealer to arrange an appointment to have your trailer repaired.
